The Ole Grey Mare, She Ain't what...

"The old grey mare, She ain't what she used to be..."

Many long years ago, the old grey mare used to be a working animal. From mail delivery to milk delivery, horses earned a place in history working in our country and in our communities. Horse Racing became known as the Sport of Kings. Only the wealthy kept horses for entertainment, most people relied upon horses for some form of economic gain and making a livelihood. Horses deemed unsafe for their jobs were rarely kept as pasture ornaments or recreational companions.

Today, although some horses are still considered working animals, most are pets or show trophies. According the American Horse Council, the numbers are 2.5 million working horses 6.6 million showing and recreation horses. Regardless of their use and purpose, they come with a very high risk of financial impact on your business, your savings, your future earnings, your health and maybe your life.

Two horse-related civil suits awarded in late 2009 were valued at 1.2 and 2.34 million dollars. The lesser amount was awarded for the wrongful death of a 21-year old woman who was thrown while taking a natural horsemanship lesson. The trail lasted eight-days in Casper, Wyoming. A second jury trial, in October 2009, awarded a 12-year old inner-city boy and his mother 2.34 million dollars in Philadelphia, Pennsylvania. The boy was a participant at a non-profit called, "Work-to-Ride". He was kicked in the face while helping as a horse was being loaded into a trailer. During the trial, there were discrepancies whether he was directed to or voluntarily hit the horse on the hindquarters with a crop. The jury discounted the original award of 2.5 million dollars by 10%--the amount of liability placed upon the boy for hitting the horse. The non-profit agency was held 90% liable for the injury.

What does this mean for you? Large cash, horse related civil judgments equal higher costs passed on to horse professionals and to horse owners. Someone or some entity is going to have to pay these settlements, today or in the future. Even the future retirement of one's spouse or an inheritance can be attached for a civil judgment as future earnings.

If judgments exceed insurance policy limits a person's personal assets and their future earnings are at risk. Regardless of the inherent risks of horses, there is never any law to protect you when a jury of your peers is convinced you caused a foreseeable injury to a person.

If you are a professional, that is money or remuneration is involved on your property or with your horse, society has greater standards about your duties to the safety and care of others. If you are a horse owner, understand that the California Civil system holds you responsible for your property and belongings and how any other person may be adversely impacted by your standard of care. This means you could easily be liable for another person that you allow to do business on your property, even if you are not compensated.

Some of the rates of injuries in horseback riding are:

- Horseback riding accounted for 11.5% of emergency department (ED) visits where non-fatal Traumatic Brain Injury (TBI) was cause of the visit (1), from Center for Disease Control.
- 82% of children's and 62% of all rider's horse related accidents are the consequence of falls from horses, from National Institute of Health.
- Head injuries comprise about 18% of all horseback riding injuries, although they are the number one reason for hospital admissions and the leading cause of death. Neurosurgery Today.
- Of horse-related injuries, 55% percent were inexperienced or beginner riders, and 10% were novice riders, from American Journal of Emergency Nursing.
- Horseback riding is more dangerous than motorcycle riding or car racing, from a review of literature for New Zealand Compensation Corporation.
- More than 2300 riders under the age of 25 years are hospitalized annually because of horseback-riding injuries, from Journal of Family Practice

Given these few statistics, resources and information that can help you avoid an accident are your first line of defense. Make sure you understand the liability you incur simply by owning or keeping a horse. Because, money is money and safety is safety and the old grey mare isn't black or white.


