

Volunteer! Help County Parks & SMHA


There are two ways to volunteer and help county parks.

- You can register for an event, like the Trail work day. You call the Park Coordinator, John George at 408.355.2299 or register ahead at the parkhere.org website. Click the **Volunteer Here** link, that will take you to the **Register for an Event** button. You must pre register either online or by calling. You do not need to be an official county volunteer to register for these events.
- Apply to be a Santa Clara County Volunteer. You can request an application on line or call 408.355.2254. The county has specific programs such as, Trail Watch, Coastal Clean up Days, and Docent, for example. This way you can dedicate your volunteer work hours toward any county use fees SMHA needs to pay. For example, the Trail Trial Clinic/Poker Ride or the Mt. Madonna BBQ necessitate a County park use permit. If a SCC Volunteer has contacted John Goldworthy, SCC Park Use Coordinator, before the club pays for a use permit,

the volunteer can dedicate their hours toward SMHA permit fees.

Tilden Wildcat Horseman's Association East Bay Hills Trails 6 day Benefit Ride

Wednesday, Sept 1--Monday, Sept. 6 Ride Labor Day week with members of the Tilden-Wildcat Horsemen's Association and the Metropolitan Horsemen's Association. Ride up to 100 miles in 6 days, or 14-18 miles each day in small groups at your own pace. Join us for one, for more or for all 6 days. The ride will follow and/or parallel the S.F. Bay Area Ridge Trail much of the time as we spend 2 days riding from each of 3 different campsites. This year's ride will be held in conjunction with the third annual 5-day Ridge Trail Through-Hike from Martinez to Castro Valley.

Trails and Camps: Camp will open on Tuesday night, so that riders can get an early start on Wednesday if they like. We will be camping at Tilden Regional Park (between Berkeley and Orinda), at Sequoia Arena in Joaquin Miller Park in the Oakland Hills, and at Bort Meadow in Anthony Chabot Regional Park. We will be sharing the campsites, and meals, with the hikers. We will be riding in Tilden, Wildcat, Sibley, Huckleberry, Redwood, Roberts, Joaquin Miller Park, EBMUD Watershed lands, and on other nearby trails. The rides will be on both fire roads and single track trails, over both flat and hilly terrain. Views of the Bay Area, the East Bay Hills, across the valley and into the Sierras will be available constantly. We will stay at each camp site two nights and move to the next one on the second day. Shower tents will be set up at each camp.

Breakfast, lunch and dinner will be provided for riders and hikers, and hay, carrots and water for the horses. Swimming will be available 5 minutes from our Tilden and Sequoia Arena campsites. Evening programs will include a visit to the Chabot Space Center, a slide show on long distance trail adventures, a presentation by a naturalist, a drill team performance, and other surprises. This is a green ride and every effort will be made to keep trash to a minimum.

Training Tip of the Week by Clinton Anderson

There are a lot of heroes in the graveyard.

When I was studying under legendary Australian reining and cow horse trainer, Ian Francis, he used to remind me that there are a lot of heroes in the graveyard. What he meant by that was that too many people get on horses that aren't ready to be ridden and get bucked off. They break their necks and die because they don't use their heads. Preparation is the key. Groundwork exercises are designed so that you can get control of your horse's feet on the ground before getting in the saddle where you have less control. Remember, there's no shame in getting off your horse if you're having problems or if you feel unsafe. The horse only wins if you get off and put him away, not if you get off and move his feet. I'd much rather fix a problem from the ground than be in the saddle wishing I was on the ground. Get your horse to respect you and use the thinking side of his brain on the ground. Then get on his back. You only get one body so take care of it.



Teaching Safe Horsemanship, 2nd Ed. Jan Dawson, Storey Publishing2003 available through www.horsemanshipsafety.com

This is a review I can make from a personal note. I spent a few days with Jan Dawson, the author, in January of this year. Jan is an attorney and a professional horseperson. This is her second book, and it is required reading for many other certification programs.

Because Jan is an attorney, she realizes that accidents, lawsuits, negligence and fear of being sued are the back door to safety. In her book she gives incredibly useful legal information, and defines negligence for us lay folks.

In California, we do not have an Equine Activities Statue, as has been accepted in 46 other States in the US. We do have a Recreational Statue which can help protect a landowner, but it is not specific in anyway to horses and their inherent risk. The pre-lawsuit preparation in Jan's


book is especially important in California. Being prepared in advance to defend against and accident is something we all should do. A person may be sued civilly for any reason, but usually with horses there is a claim of negligence.

The biggest component of Jan's book are the step-by-step verifiable exercises that form building blocks to safe horsemanship and its defense. If knowledge is power, this book is truly a battery pack.

An appendix in the book written by the late Robert Dawson, Bryant Smith Chair in Law, University of Texas School of Law, is titled Dealing with Accidents and Lawsuits. This appendix walks you through what happens when a person is sued, from the filing -to the defense and settlement or judgement.

Remember, insurance is what we purchase to pay for defense in the event of a lawsuit. Understand your policy, it's limitations and exclusions. Jan's book even discusses the reasoning behind selecting policy limits.

In fact, lawsuits happen much less frequently than we think, most suits filed are settled out of court by the insurance company. Your insurance company wants to avoid time in court just as much as you do!
